SAFETY ALERT!!!

Recently, there have been several reports of suspicious vehicles, theft and vandalism in and around Cedar Ridge and neighboring Fir Ridge. Two homeowners reported catalytic converters stolen, one from a motor home, the other from a Toyota Prius. A white Honda was spotted in the area at the time the motor home was vandalized. The Pierce County sheriff's department was called, and reports were filed. The same white Honda sedan was recorded driving through two homeowners' yards in the early hours of the morning. A Prius was reported stolen from a property in Fir Ridge. A suspicious black GMC Yukon truck was also observed driving through Cedar Ridge the day before the thefts. One of our board members called The Pierce Co. Sheriff to request extra patrols in our neighborhood.

If you see something (visually or on your home security cameras), SAY SOMETHING right away. We've been advised that we need to call the Pierce County Sheriff nonemergency number to report any suspicious activity or problems right away. That number is 253-287-4455, then press option 1 to be connected immediately to someone from the department. If there is a patrol car in the area, they will do a drive through to check things out.

There are things we can do to deter future crimes. Please make sure to lock all your doors and windows, both to your home and vehicles, and don't leave valuables in your cars. Keep your driveway and front porch lights on at night. If you can't park in your garages, back your vehicles as close to your garage doors as possible and close together to minimize access to your vehicle under carriage. Lock up all sheds, and don't leave ladders outside and accessible to prowlers.

The board is looking into holding a community meeting with a representative from local law enforcement, to further educate our neighborhood about what other things we can do, and what law enforcement can and cannot do, now that the laws have changed. We could use a volunteer to be a liaison to law enforcement as well.

Volunteers Still Needed!

Currently, we are looking for a committee chairperson for the Safe Streets committee. This is especially critical with the recent illegal activity in and around our neighborhood. Please contact a board member if you are interested.

We also need a volunteer to chair the elections committee. This would only be for 1 year.

Elections Committee Responsibilities

Formed to run an open and fair election of new board members. Responsible for advertising the election, being the contact for candidates, as well as distributing and collecting ballots. All election committee members are to be appointed by the current Board of Directors. You must be a member of CRHOA in good standing, and not be running for a position in the upcoming election.

There is one position available on the current Board of Directors, for Vice President. This position is for one year and is appointed by the board. If you wish to be considered, please contact any board member and we would love to talk to you!

Skillet Chicken with Sundried Tomatoes

2lb.Boneless, skinless chicken breasts Salt and pepper, to taste

5 TBSP butter, divided

3 garlic cloves, minced

1 tsp Italian seasoning

½ tsp crushed red pepper flakes

1/2 cup unoaked Chardonnay or Sav Blanc

1 Cup chicken broth

34 Cup heavy cream

½ Cup oil packed thin sliced sun-dried tomatoes

1/2 Cup thinly sliced fresh basil

Pound chicken breasts to an even thickness in a zip-top plastic bag using the palm of your hand or meat mallet. Season with salt and pepper.

Melt 2 TBSP butter in a large nonstick skillet over medium heat; add half of the chicken and cook 3-4 minutes per side or until done. Remove from skillet. Repeat with 2 TBSP butter and remaining chicken.

Melt 1 TBSP butter in skillet over medium heat; add garlic, Italian seasoning and crushed red pepper flakes. Cook, stirring constantly, for 1 minute.

Add wine; bring to boil, reduce heat and simmer 2 minutes. Add broth; bring to boil, reduce heat and simmer 5 minutes. Stir in cream and tomatoes; simmer 5 minutes.

Return chicken to skillet; stir in basil. Cook 4-5 minutes or until chicken is thoroughly heated and sauce is thickened. Makes 4-6 servings.
