Just a friendly reminder, per CCR <u>4.3</u>
<u>VEHICLES</u>. Starting (1) week after Labor Day (September 9<sup>th</sup>) no recreational vehicle and/or commercial vehicle, including but not limited to boats, campers, motor homes, trucks in excess of 3/4 ton, and trailers of any kind shall be parked, stored, maintained or constructed on any Lot or street in such a manner to be visible from the street or neighboring lots, except that portion extending above the maximum height of the required fence.

A few days/ weeks after, we noticed a hard lump on his rib cage that doubled in size within a 24hr period. After a few trips to the vet, he was diagnosed to have Actinomyces, which involves prolonged 2 doses, 2x/day for several months of antibiotics and potential surgery.
