Neighborhood Safety Issues

Street Lights

Several trees have grown up and over the street light poles blocking light and/or the light sensor. The street lights where erected to provide lighting in the neighborhood in an effort to keep our streets safer. If the trees are blocking the sensors on the light poles then the lights will remain on 24/7 which increases the CRHOA power bill. It is the responsibility of the homeowner to keep the light poles clear of obstructions. If you need assistance, please contact any Board Member.

Winter Issues

With inclement weather upon us it is vitally import to keep storm drains free of debris to prevent flooding.

If you have graveled areas in and around your lot at the edges of driveways or the street, please take the time to remove any gravel or rock that has migrated onto street surfaces to prevent further problems.

Architectural Control Issues

Approval by the ACC is required before any building, structure, shed, fence, or exterior addition is started, erected, or altered upon any Lot. This includes any exterior painting of said building or structure.


