Agenda: Approve meeting minutes. Address homeowner questions and concerns. Discuss ongoing HOA business and compliance issues.

Treasure Report: Treasurer report approved. President addresses questions regarding our 3 power bills. Dues as of 3/9/23 2020 1 remaining, 2021 3 remaining, 2022 9 remaining. 2023 46 remaining. Dues are accepted through Cash app for 2023.

Homeowner questions: What is Cash App and how does that work. Answer: It is an app that allows for electronic transfer of funds between people. Homeowners may pay their dues to the HOA Cash App account. The money is then transferred from Cash App into the HOA bank account. This has been implemented to keep up with the changing times.
