### WHAT THE CLUCK?



Cedar Ridge does <u>NOT</u> allow chickens with the exception of emotional support animals (ESA) allowed under Washington State's Fair Housing Act (FHA). Because ESA chickens have been a question in recent years, the Board is explaining that even if we must allow for therapy purposes the Homeowners will have to abide within the rules set for this exception. Before the chickens come home to roost...

- You must submit a Doctor's ESA letter.
- The Board would like to see a yearly letter submission.
- No roosters! Cock-a-doodle-doo! They are noisy and not allowed in Pierce County.
- PU! You must maintain a regular disposal of waste.
- No free range chicken runners. They must be enclosed.
- The coop requires ACC approval
- For safety & nuisance reasons of sight, smell ,& noise. 20 feet from any house
- Let's not put the coop away from your home, but up against your neighbor's fence line. ESA chickens are for your therapy not to drive your neighbor mad.
- We will be limiting the size of coops. Generally 4 square feet of coop space per standard breed chicken. (e.g. 5 chickens = 4' x 5').
- Limiting the amount of chickens. Under Wa state law: Urban areas under 1/2 acre lots only allow 5 fowl.

The placement & size of coop and amount of chickens is for the safety of all our Peeps. We don't want to attract local Coyotes. Living in a HOA community requires us all to be considerate of each other. Looking out for your neighbors makes Cedar Ridge egg-straordinary!

The By-laws were last updated in 2010. The CCR's have never been updated. One article on Recreational vehicles was added in 2010 to the CCR's after being put on the ballot and homeowners overwhelming voted to pass it. With all the changes in our States RCW's, new materials for home building, roofs, fencing and rules our Association wants to operate under, it is understandable that we need to up date our governing documents.

We have added "proxy voting" to our proposed by-laws. A proxy vote means a vote cast by one person as a representative of another. A homeowner delegates their voting power to another homeowner.

A proxy vote allows one member or homeowner to vote for another member or homeowner when they can not attend the annual meeting.

The member or homeowner may appoint a "proxy" to vote/act for another member or homeowner by executing an "appointment form" in the form of a record.

The form to be filled out will be available on the Association's web site. The form must be filled out and submitted to the Secretary of the Board one week prior to any meeting where specific voting is to take place that the homeowners have been notified will take place. The form is good for 6 months at which time another appointment form may be filed if needed.

We hope this will allow homeowners a chance to vote on we issues when they are unable to attend a meeting and will also help us meet quorum when voting on certain issues. This procedure will not be used for elections for Board positions or ballot votes to pass the CCR's or By-laws.




