

- End with Refreshments at Fir Ridge Park on Left.




Neighbors helping Neighbors

By-Laws Changes by the Rewrite Committee

Dissolution of the Association

The original By-Laws did not list the steps of dissolution. The By-laws Committee proposes adding the following subject information to the revised Bylaws from current law. . . .

The Board of Directors or 10% of the Homeowners shall call for a special meeting to discuss and propose dissolving the Association. The Board will discuss the purpose of dissolving and what is involved, including but not limited to lights turned off, mailboxes no longer repaired, water shut off, no more landscaping done at front entrance, no community events and other pertinent information. The Board will explain how the assets will be distributed once all creditors are paid and how the distribution of assets will be determined. A vote to dissolve the Association will be done by sending a ballot to each Lot Owner. Once quorum is met (31ballots returned) 67% of the all Lot Owners or homeowners must vote in favor of terminating the Association to dissolve.

After dissolution is authorized, the Homeowner's Association must file with the Secretary of State's office "Articles of Dissolution".
